

ENTRY REQUIREMENTS:

English proficiency can be shown by meeting criteria like education in an English-speaking country, completing at least 6 months of a Certificate IV level or higher course in an Australian RTO, achieving upper intermediate level or higher in ELICOS studies, or passing APIC English Placement Test. Those lacking documented evidence in English competency, may undertake the LLN test online to meet the English requirement.
